1. Introduction

The Mental Capacity Act 2005 (MCA) provides a statutory framework for people who lack capacity to make decisions, or who have capacity and want to make preparations for a time when they may lack capacity in the future. It sets out who can take decisions, in which situations and how they should go about it. The Act applies to all those involved in providing health and social care in England and Wales.

This audit tool can be used in primary care to assess how well your practice is performing, and will demonstrate gaps where changes may need to be made.
